2015 Remedy (McCloud) timeline

01 April 2022

 By this date, all active 2015 Remedy (McCloud) in scope members, in service, are now in the alpha scheme.



June 2024

- From June to August 2024 we will be sending out all Annual Benefit Statements (ABS). We are aiming for all active members to receive their Remediable Service Statement (RSS) breakdown in the 2024 Annual Benefits Statement (ABS) by 31 August 2024. No choice is needed at this stage, this RSS is for information only.
- Please note if you haven't done so already, you will need to register for the portal to see your ABS. This can be done <u>here</u> (Note: If you have previously requested a paper copy this will be sent to you.)

1 October 2023

- · Remedy legislation will now be in place.
- Any member informing us that they wish to retire after 30
 September 2023, will receive an expanded quote pack in the
 post which outlines two retirement quotations under their Legacy
 (classic, classic plus, premium and nuvos) and Reformed scheme
 (alpha). This is known as Deferred Choice Underpin (DCU). At the
 retirement stage, you will be required to choose the benefits you
 wish to receive for your service within the Remedy period (I April
 2015 31 March 2022). You can submit this choice to us by post or
 email via the form provided in your quote pack.

By 31 March 2025

Retired members will receive a Remediable Service Statement
(RSS) in the post, providing them with their Immediate Choice
options for both Legacy (classic, classic plus, premium and
nuvos) and Reformed scheme (alpha). You will receive a
key choice illustration document and additional supporting
information to help you decide on the benefits you wish to
receive for your service within the Remedy period. You have 12
months to make the choice (from the date of letter) and you will
be asked to submit your choice to us online however, if you are
unable to do this you can submit your choice by post, via the
form provided in your immediate choice pack.





Scheme consultation and legislation

- The public consultation concluded in August 2023 with the publication of the consultation outcome report.
- There were no material challenges to the draft regulations.
 A further regulation concerning club transfers was inserted.
 This will only impact a small number of members wishing to retire soon after 1 October 2023.
- The scheme regulations to bring into force the 2015 remedy effective from 1 October 2023 were laid in parliament on 6th September.

Programme update: Remediable Service Statements


Remediable service statements for the immediate choice (retired) members will be made up of:

- Cover letter;
- Choice illustration;
- Supporting information;
- Choice form choice can be returned by post or made digitally.
- These will start to be issued from Spring 2024. All RSSs must be issued by April 2025

Other:

Work continues developing the digital portal for recording the members choice.

Member testing has been taking place on transitional quotes.
