### Important announcement: deceased members

As Branch Membership Secretary, I would like to take this opportunity to explain to members why, on occasion, branch newsletters are sent out to recently deceased members.

To meet printing deadlines, the mailing list of 'active' branch members is sent to the printers by head office staff in Croydon at least a month prior to the newsletters being posted to members.

Scotland Branch does not have the capability or facility to do this, so it is carried out on behalf of the branch by head office. At the end of every calendar month. MvCSP. the pension provider, gives head office a list of deceased members names. This is usually where the difficulty arises, so there is nothing anyone can do to stop the occasional newsletter being sent out to a recently deceased member.

I appreciate that receiving mail addressed to a deceased loved one can cause distress, but although my contact details are at the bottom of this newsletter, I have no control over the distribution of the newsletter.

I hope this explanation helps you, as Branch members, to understand the logistics involved in sending out the newsletter.

# Report from CSPA Annual General Meeting

At the national AGM, held in Kenilworth on 11-12 October, Scotland Branch was represented by Wilson Macdonald and Christine McGiveron (Executive Council members), Cherry Dolan (delegate) and Michael Kirby (sponsored representative).

The AGM was opened at 2pm

by Kenilworth Deputy Mayor Alan Chalmers. CSPA General Secretary Sally Tsoukaris gave her first AGM speech, presenting the annual report. The statement of accounts was moved by National Treasurer Mike Sparham and adopted by the AGM, and a

Certificate of Merit was given to outgoing General Secretary Lisa Ray recognising her work for the CSPA.

Guest speaker Angela Saunders from the Lifeboat Fund – the civil service charity that raises funds for the RNLI – told us about the organisation's campaign to raise £18,000 each for lifeboat stations at Whitby, Tower (London), Blackpool and Stonehaven, and also help for crews on Lake Tanzania in Kenya.

On the second day of the AGM, Stella Humphreys from the Cabinet Office gave a presentation on what is happening regarding the McCloud remedy for pensions after 2015 and before 2022. The legislation to deal with this was put in place on 1 October and those affected will receive remedial statements in the year commencing April 2024.

There was a very interesting presentation on Independent Age's campaign to support having a Commissioner for Older People in England and Scotland (Wales and Northern Ireland already have one).

The AGM closed with a vote of thanks given by Les Priestly, EC member.

# Scottish Older People's Assembly

Branch Officers attended the SOPA 2023 Assembly in Glasgow on 9 October, where there was a CSPA Scotland Branch stall.

Professor Jason Leitch (pictured), National Clinical Director of the Scottish Government and Senior Clinical Adviser to the Scottish Government, gave an extremely informative speech regarding the decisions made during the early days of the Covid-19 pandemic.

He has been highly praised for his ability to translate complex

scientific information to the public, providing calm, clear advice during the unprecedented circumstances the world was facing. He delivered his speech to the attendees in an unusually entertaining manner, without losing the understanding of the severity of this new disease.

SOPA Chair David Paterson gave the annual update and the event proceeded with members' statements – including from African Caribbean Elders, Lanarkshire Unite Retired Members Association and LGBT Health, to name but a few. It was chaired by Teresa Lavery, SOPA Trustee.

An update was given by Tony Donohoe on age-friendly communities. Various workshops



were then organised and after lunch a cross-party panel of MSPs answered questions online.

This was followed by a debate on SOPA priorities for the coming year, chaired by Teresa Lavery and Catriona Mason, both SOPA Trustees.

It is hoped that SOPA events such as this will prove to be a valuable recruitment opportunity for the Branch, as it is not widely known that becoming a member of the CSPA is not reserved only for retired civil servants but is available to those in public service such as the NHS and the teaching profession.

Two such attendees approached our stand and Michael Kirby gave his business cards to them in the hope they would consider membership and spread the word.
