The national AGM took place in Coventry in October. Keith Yallop was there in his capacity as chair of the Standing Orders Committee, and of course I attended as delegate from our group.

There was of course real disappointment at the government's decision to restrict the winter heating allowance to fewer pensioners. The CSPA was at the forefront of campaigning on this issue but to no avail. Since the AGM we have had the budget with its commitment to the triple lock for the state pension, and CPI inflation increase for the civil service pension. We cannot relax on any of this.

The new travel insurance scheme, offered through the Civil Service Insurance Society to CSPA members at competitive, fixed rates based on age categories on a 'fit to travel' basis, is proving to be popular with our members.

Annual policies, renewable each July, can also now be purchased part-way through the year on a pro rata basis, so members taking out policies in between renewal dates will not have to pay the full amount.

Minutes of the Group Meeting of 14th June 2024

The minutes were taken as a true record. There were no matters arising.

Secretary's Report

John said he was still sending out info to people who were on his email list and sending copies to David by post. John raised the issue of whether we should still have minuted meetings. It was decided that we should. John informed the meeting that Middlesbrough Council were evicting St. Mary's from its building. For the lack of suitable alternative accommodation, the charity had decided to fold. The Centre had been the venue for group meetings for many years and members expressed thanks for the support given by Eileen the Centre manager. In recognition of this the group voted to give Eileen a fifty pounds gift voucher out of our funds and a card was signed by members present thanking her and wishing her well in her retirement. Treasurer's report

Keith reported that total funds of the Group amounted to £868.14 in the bank account and £33.47 was cash in hand. Total £919.61. It was again agreed that a voluntary subscription would not be requested in 2025. Keith requested that members be written to ask that any standing orders be cancelled before the new year. Keith, Christine and John had met again to complete the documents to clear up with Barclays who were our signatories and who was our Treasurer. This was effectively Barclays' last chance. The report was accepted with the thanks of the meeting.

NPC Report

Following his wife's recent death Keith had given up his role as Treasurer for the regional NPC and effectively severed his links with it. No other member volunteered for the role and it was likely our affiliation would cease.
