# Mayoral Strategic Authority – South West Peninsular



The proposed new local government will receive the transfer of powers and funding from central government to Mayor and local Unitary Authority level who will be making decisions closer to local

people, communities and businesses.

The Government White Paper indicates Mayors will manage an integrated/consolidated fund for Unitary Authorities, giving a stronger community engagement and deliver genuine opportunity for neighbourhood empowerment. They will deliver the services of housing, planning, transport, energy, care, education, skills, employment-support and more to suit local need in the unitary authorities. That in our area is Devon, Cornwall and Plymouth

In essence it removes the present two tier County/District Councils undertaking differing services to be replaced by a single Mayor led Group delivering all services through Unitary Authorities of no less 500,000 residents. The proposal for the South West Peninsular is that the elected Mayor will oversee the unitary authorities of the newly formed Devon (Devon 811,500<sup>1</sup> & Torbay 139,500<sup>1</sup>), with

Plymouth 264,600<sup>1</sup> seeking to double their area of authority to towns close by, while Cornwall 570,400<sup>1</sup> has rejected the idea as they wish to pursue. The Government is clear in the need to find a solution though negotiation by 2027 for implementation around 2028.

Given this change it makes sense to reform the Groups to mirror that change so we have one voice to influence those decisions in delivering local services that affect the retired such as housing, transport, care etc through actively lobbying the Mayor and Unitary Authorities. If CSPA is to run an effective non political campaign there is a need for an active local Group.

## **Living Pension**

We have a two living wages for those that work yet we have two state pensions that fail those who have retired on low savings and low or no personal pension. Why can't those retired expect to receive at least a liveable income to cover the essentials? We know some two million pensioners are categorised as struggling in poverty. As the pension rises above the fixed pension credit

threshold more will fall into extreme poverty so they will need support and we will pay for it partly by hidden taxes to cover that
