Welcome Back

The Committee welcomed back Chair, Mike Buckley, after an enforced absence due to ill health, and wished Beryl Wardley a swift recovery.

Group Financial Status/2025 Group Subscriptions

The Committee unanimously endorsed the Treasurer's report – see Page 3.

Group Membership

Linda Woollen reported that membership is currently stable, but it's still really important for the future of the Group that we do all we can to identify potential new members, recruit them and encourage their participation. The report and proposal were noted and endorsed by the Committee.

<u>Expanding Group Coverage and Informing and Consulting Group Members</u> - We are working with Andy Aitchison, North East Regional Representative, to explore if and how we might provide a service for Members in Lincolnshire who no longer have an active Group.

The Committee noted that the National Treasurer has budgeted for 2025 on the basis of current Group circulation costs. Any attempt by us to add to hard-copy Newsletter circulation is unlikely to be agreed by the NEC. In looking at any potential involvement, we agreed the following approach:

- i. Recognise the need for CSPA to modernise its communications and to contain expenditure
- ii. Make it clear to HQ that we are content not to increase our hard-copy Newsletter distribution, unless otherwise instructed.

- v. Ensure that any action we agree to undertake will not be detrimental to our service provision for existing members.

NEC Proposals for a 2-year All-Member Ballot trial

The Committee discussed in some depth how we should respond to this proposal trial.

Committee Members expressedd real concerns about its potential detriment to the role of Groups and the loss of a knowledge-based approach to selecting and electing candidates, it is vital that we get a full cost/benefit assessment from the trial of this methodology. We will keep this under review. The Group Committee would welcome your views.

Subscriptions for the year started very shakily and it necessitated a warning to the committee that funds might not last until 2025. Your annual subscription to HQ CSPA covers the issue of the Pensioner 4 times a year, our newsletter 4 times a year and of course HQ costs. Your group therefore is reliant on local support for all other costs which we incur on your behalf. However following the reminders in our newsletters, the position recovered and now stands at a healthy £2300. We are extremely grateful to members who have contributed to the continued financial health of the group by not only paying the voluntary subs but have been very generous with donations too. However, only approximately one fifth of our membership has been able to support us financially.
