#### **WEST MERCIA GROUP**

CSPA West Mercia Group began life in February 2022, following the merger of the Hereford & Worcester Group with the closed Shropshire Group. We have over 700 members in the Three Counties. CSPA nationally has about 34,000 members.

Our informal quarterly meetings last no more than 2 hours. Those held at Hereford and Worcester are preceded by an optional pub lunch. Meetings end with tea and biscuits. We plan to complement the inperson meetings with occasional online gatherings using the free Zoom platform. We also produce a seasonal newsletter which we aim to issue at least 3 weeks before each quarterly meeting.

## **YOUR CIVIL SERVICE PENSION**

**MyCSP** pays your Civil Service pension. Its contact details are: MyCSP, PO Box 2017, Liverpool, L69 2BU; Phone: 0300 123 6666 (Mon-Fri: 0830 -1800). There are various "what to expect" guides. You can also register for the **Civil Service Pension Portal**, which gives online access

to your pension information. If you experience any problems with your pension, which MyCSP can't or will not resolve, please contact the Group Secretary for help and initial advice. More complicated matters will be referred to Christine Haswell, the CSPA Pensions & Personal Case Manager at CSPA HQ, to pursue.

MyCSP has experienced problems in recent months delivering its service to the standards expected by the Cabinet Office. CSPA nationally has been in contact with the Cabinet Office, which has implemented a "recovery plan" including additional staffing for the MyCSP call centre. The contract for managing the Civil Service Pension Scheme has been awarded by the Cabinet Office to Capita for 10 years from December 2025. Capita held the contract prior to MyCSP. CSPA is in close contact with the Cabinet Office to ensure that the transition from MyCSP to Capita goes seamlessly.

The Parliamentary Public Accounts Committee is currently enquiring into the administration of the Civil Service pension. #### **WEST MERCIA GROUP MEETINGS IN 2025**

Our Group meetings for the remainder of 2025 are as follows:

Our 17 March 2025 meeting in Worcester elected the Group Officers etc for the coming year (see overleaf) and adopted the Statement of Accounts for 2024. The 16 June meeting in Hereford approved a nomination for election to the CSPA Executive Council and devised 3 motions for discussion at the CSPA 2025 National AGM in early October. All 3 of our motions – on **energy prices**, **banking hubs**, and the **CS Pensions Board** - are on the National AGM agenda. The Shrewsbury meeting on 15 September will give a steer to Malcolm Moore, our delegate to the CSPA National AGM. The 8 December meeting will review our activities in 2025 and make plans for 2026.

Meeting reminders appear in the quarterly Group newsletters. Members of our email group receive copies of the meeting papers. If you cannot attend a meeting but have a bee in your bonnet about an issue affecting older people that you think can usefully be discussed, please contact David Humphreys, our Group Secretary.

## **KEEPING YOUR PERSONAL AFFAIRS IN ORDER**

The consumer guru, Martin Lewis, regularly extols everyone, regardless of age, to keep their personal affairs in order. In particular, he emphasises the importance of:

- Having an up-to-date will CSPA members who don't have a family solicitor can get free legal advice from Lyons Davidson on 01752300584, who can also advise on their likely charges for drawing up a will (https://www.lyonsdavidson.co.uk)
- Making and registering Lasting Powers of Attorney, covering Health & Welfare, and Property & Financial Affairs <a href="https://www.gov.uk/power-of-attorney">https://www.gov.uk/power-of-attorney</a>. It costs £82 for each LPA, and our Group Secretary found it straightforward to prepare ones for himself and his wife online.

One of our members also recently experienced some difficulties in securing her **property deeds** from her solicitor. Many solicitors are no longer prepared to store property deeds, so it's worth checking that your deeds are secure and/or are easily accessible.

## "LATER LIFE AMBITIONS" CAMPAIGNS

"Later Life Ambitions" (LLA) is contracted to represents the nearly 160,000 members of the CSPA, the National Federation of Occupational Pensioners (NFOP), and the National Association of Retired Police Officers (NARPO). Its manifesto - <a href="https://www.laterlifeambitions.co.uk/manifesto">https://www.laterlifeambitions.co.uk/manifesto</a> - was launched at a Westminster Parliamentary event in November 2023 and sets out six aims for a better future for the 11 million older people in the UK.

## **THE CHARITY FOR CIVIL SERVANTS (CfCS)**

**CfCS**, formerly the Civil Service Benevolent Fund, helps current and former civil servants with whatever problems they may have. Its vision is of a lifelong community of people offering effective support for each other when life takes a turn for the worse. Support includes financial assistance and a range of services, including help with bereavement, residential care, relationships, caring, dementia, and long-term illness. It works with specialist organisations — such as Macmillan, Dementia UK and Relate — and signposts other helpful advice. One of our members recently received a substantial CfCS grant to revamp her bathroom to accommodate her declining mobility.

## **THE NATIONAL PENSIONERS CONVENTION (NPC)**

CSPA is affiliated to the **National Pensioners Convention** (NPC), the largest pensioners organisation in the UK. NPC campaigns for and promotes the welfare and interests of all pensioners and older people, as a way of securing dignity, respect, and financial security in retirement. It organises rallies, lobbies of MPs, and makes submissions to Government on policies affecting older people. Its 2024 Biennial Delegate Conference elected the NPC national officers and determined its policies and priorities until 2026. NPC also stages an annual 2-day "Pensioners Convention" in Blackpool. Sadly, current financial difficulties mean that the 2025 event has been postponed until 2026.

NPC's monthly bulletin "Campaign!" is sent by the Group Secretary to the 150 members of our email group. The latest edition of Campaign contained articles on the successful campaigns on Winter Fuel Payment and the Warm Homes scheme; action on Climate Change; and news from the NPC Regions. The NPC also has several working parties covering a variety of topics and which issue regular newsletters.
