It's Time to Reconsider

We need to recognise that there are those who struggle with daily expenditure as they have income below the recommended amount for a one-person household pension income of £14,400, or two-person £22,400 (Joseph Rowntree Foundation 2025), (editor – A Living Pension to mirror the Government set living wage). Many will be individuals who took career breaks and /or in low paid jobs, and whilst I would like to think that none of our members struggle, the statistics would indicate that may be incorrect.

Nationally there are 1.9m pensioners (16% - UK Parliament - Pensioner Poverty) living in poverty which is defined as someone with an income of less than 60 per cent of average household income after housing costs (£17,600 Govuk 2025), so it was pleasing to read that the take-up of entitlement for Pension Credit has risen and once accepted it opens up doors to other entitlements. Each year there is a battle with the authorities to ensure that those who need help to survive in retirement are supported.



There are those that do struggle to stretch their budgets and do not qualify for Pension Credit who will have more difficulty in accessing support when Sorry, 1 am retired. _ in extreme need through Government or charity funds, additionally those above the static tax threshold will see their future pension rises reduced by

pension rises reduced by twenty percent tax payment placing them further behind inflation.

We need to think laterally and review the present funds and cost of administrating to top up income with additional entitlements that should in the future be accessed through just one department for those below the acceptable limits set by Rowntree Foundation. If it proves there are insufficient funds now there may be a need to find a compromise but let us, at least, get the commitment and lay the foundation for the future move towards the Rowntree Foundation minimum incomes by campaigning with other organisation to ensure all those in need are supported.

If you are below the one person £14,400 or two person £22,400 and having difficulty in meeting your commitments, I would welcome your story in confidence to determine how best to campaign.

Note: Qualifying for Pension Credit is complex and income can be above the stated entry level and still qualify.

AGM 2024 Success

It was good to see last year's East Devon motion A41 had achieved results as we had voiced our concerns - that cyclists who are inconsiderate are a danger to those with limited mobility given the need to cross cycleways to board a bus or to avoid those riding bicycles on the pavement or in pedestrian areas.

We asked that those who offend are fined nearer to the maximum and that illegal electric bicycles that travel at more than 15 miles an hour be taken off the road and that any fines of those and others riding bicycles on pavements or in pedestrian areas inconsiderately be widely publicised,

It was therefore not unexpected that when Birmingham Police task force focused on illegal bicycles, some capable of 40 miles an hour, that they impounded them and they were given full prime time publicity on national television news in July this year.
