WHY THIS SURVEY MATTERS

The CSPA is considering a move to an all-member ballot for EC elections

Follows growing concern over limited access to democratic structures

This consultation was designed to gather views across the membership



HOW THE CONSULTATION WAS RUN



Two surveys: one for individual members, one for groups/branches



Managed independently by Connect in collaboration with CSPA



Both print and online formats used to maximise accessibility




WHO TOOK PART?

1,353 individual responses received from across the UK

27 Groups and Branches submitted formal feedback

Responses reflect a wide range of member experience and views







LENGTH OF MEMBERSHIP & RETIREMENT


76% of respondents have been retired over 10 years

58% have been members for more than a decade

Respondents show long-standing commitment to the CSPA

WHY MANY CAN'T PARTICIPATE



43.7% say they do not feel able to take part in CSPA democracy



Main reasons: no local branch, unclear processes, low visibility



"Without a branch, I have no link to the decision-making process." Member, West Midlands

Over 1 in 5 are dissatisfied with communication from the EC




"I've been a member for over a decade and never really understood how decisions are made."




Support for all member vote






Would vote in all member ballot









WHAT GROUPS TOLD US



100% of groups reported they are engaged in democratic activity



Most groups meet regularly and publish newsletters



Groups remain central to CSPA's local engagement



VIEWS ON ALL-MEMBER BALLOT SYSTEM



60-70% of Groups support the all-member ballot system in principle or as a trial



Concerns: candidate visibility, complexity, impact on branches



"In theory yes, but in practice no – members don't know the people standing" – Clacton Group



SUPPORT FOR A TRIAL



75-80% support a two-year all-member ballot trial before full adoption



Few groups opposed; most wanted to test approach first




"Yes, it will allow time to test the new system" – Chester Group



PREFERRED VOTING METHODS







80% of groups favour a hybrid approach (postal + online)

Many flagged accessibility needs: large print, braille, alternatives

"Combined online/postal – but should also be available to those without internet" – Nottingham Group

More accessible and fairer elections



Clear, simple information about voting and candidates




Voting methods that fit personal needs and confidence



KEY RECOMMENDATIONS







Offer both postal and online voting



Invest in clear, accessible communication



Ensure the allmember ballot system supports branch structures



Support and encourage diverse candidates



Closely monitor and evaluate the trial
