Welcome to the New Year newsletter. This issue focuses on some planned changes to the democratic process within the CSPA, plus the implications of some policy announcements from government, including the Autumn Budget. There is also notice of group meetings which you may wish to attend. Our regional representative, Harry Brett, covers news of interest including our local 200 Club winners.

PENSIONS INCREASES ANNOUNCED IN THE AUTUMN BUDGET 2025

Both the basic and new State Pensions will increase by 4.8% in April 2026. Pensions Minister Torsten Bell has said that over 12 million pensioners will benefit by up to £575. Pension Credit which protects the most vulnerable is also set to increase by 4.8%.

However, the Triple Lock – whilst guaranteed for the duration of this Parliament – remains vulnerable. The Office for Budget Responsibility (OBR) believes that spending commitments by the government (particularly on healthcare and pensions) are unsustainable.

The CSPA wishes to see the Triple Lock maintained. We are tracking press coverage of these issues. If you would like to see copies, please let us know. We are also campaigning for a Minimum Income Level required to sustain a basic but healthy and decent standard of living in later life.

Civil Service pensions will rise by 3.8% from 6 April 2026.

Civil Service trade unions are calling for action on the civil service “gender pension gap”.

TAX THRESHOLDS FROZEN

The Autumn budget confirmed that tax thresholds will continue to be frozen. As pensions increase, many more pensioners will see themselves subject to payment of income tax. This will benefit the Treasury but continue the pressure on pensioner cost of living.

ANNUAL GENERAL MEETING DECISIONS

John Jenkinson attended last October's AGM on behalf of Greater Manchester Group. A full record of all AGM decisions has been published in-house and is available on the CSPA Website. Alternatively, you can request a paper copy from us or from the National Office.

Harry Brett was re-elected as Regional Representative for the North-West, and Pam Flynn was re-elected to the Executive Council.

CHANGES TO BALLOT ARRANGEMENTS FOR ELECTION TO EC POSTS IN 2026

The AGM agreed a change to how EC members are elected. Starting with the 2026 AGM in October, there is to be a two-year trial of individual balloting of members, replacing the Group and Branch "block vote". Individual CSPA members will be able to nominate EC candidates and cast their votes online or by post. Information on the proposed changes, including the Ballot Timetable, will be given in the March and June issues of the Pensioner.

CONSULTING ON CSPA STATUS

There will be a round robin regional meeting to be held in Manchester at the Methodist Hall Oldham Street which will explain to members a possible legal change to the CSPA's organisational status. This is covered to some extent in the December issue of the Pensioner (page 11) but will be covered in more detail at this meeting. Representatives have been invited from all Groups in the Northwest, Northeast and Wales. The meeting will take place on Thursday 23 April between 11-00am and 3pm. The meeting which will also be taking place in other parts of the UK will be attended by the new Deputy General Secretary, Bernard Seymour from Affinity Resolutions and Mike Sparham, the National Treasurer.

REGIONAL NEWS

The Northwest has managed to retain 4 active Groups – Chester, Greater Manchester, Liverpool and District and the Wirral. We have 5 non active Groups – Blackpool and Fylde, Cumbria, East Lancs, Morecambe Bay and Preston and Chorley. I have attempted over the last 2 years to try and re-start these Groups by visiting the area and inviting members to come and meet me, but unfortunately there is little desire to re-start the Groups. This was what led me to push for individual member voting on EC elections which allows individual members to have some involvement.
