SECRETARY'S COLUMN

CSPA is proudly apolitical. It doesn't take sides. It is there to push the case of pensioners, whatever the government in power. So, CSPA will always campaign, on your behalf, and with your direction (via AGM motions etc.). As a result, we have clear and concise policies on the state pension, the triple lock, your occupational pension and negotiations with the Cabinet Office, health and social care, digital exclusion, public transport services, housing policies, banking facilities, a commissioner for older people and so much more.

The end of 2025 brought a second Rachel Reeves budget, following the Labour Party's election in June 2024. So what did that mean for us pensioners and how will that affect our day-to-day lives in 2026? The Chancellor confirmed that, next year, under the "triple lock" policy, the basic and new state pension payments will go up by 4.8% to £184.92 and £241.30 a week respectively. The Civil Service pension increase for April 2026 will be 3.8%, as determined by the September 2025 Consumer Price Index (CPI) figure. Inflation, for October 2025 stood at 3.6% with forecasts for 2026 (for what they are worth) ranging from 2.3 to 2.6%.

Personal Income Tax and National Insurance thresholds will be frozen for a further three years to April 2031, meaning that more and more pensioners will fall into the basic and higher tax brackets. Household energy bills should be reduced by £150 by moving green levies and rail fares and NHS prescription charges are frozen for one year.

The government's priorities currently seem to be, spend now and hope this will induce growth. Later, when financial constraints get tighter, growth will kick in, and there will be enough headroom anyway. A big gamble. We shall see. Meanwhile, us pensioners still seem to be in a slightly happier position than most. We still have the triple lock. We still have the grey vote lobby. We still have CSPA campaigning for us. You can get involved in our meetings and democratic processes. Change things! Play your part! Stay faithful !

13th January	The Samaritans: This charity provides a non-judgemental and confidential listening and support service for anyone struggling to cope. It also campaigns on suicide prevention. Our speaker is Marion Watson.

10 March	Benjamin Beeson: Local historian Phil Swallow will tell us about Benjamin Beeson, who fought in the Charge of the Light Brigade in the Crimean war. He later worked in this area in the mounted division of the Metropolitan police.
