He joined CSPA on retirement in 1994, hardly missed a Group meeting, and variously held the offices of Group Chair, Vice Chair and Treasurer. We understand that a memorial service may be held in the Spring, and we will gladly share the details when known.

## **YOUR CIVIL SERVICE PENSION**

Capita Plc was contracted by Cabinet Office from 1 December 2025 to administer the Civil Service Pension Scheme for the next 10 years. Its contact details are Capita Pensions Solutions, PO Box 713, Darlington, DL1 9JZ; Phone: 0300 123 6666 (Mon-Fri: 0800-1800). The Civil Service Pension Portal gives online access to your pension information, and provides an online contact form. If you experience any problems with your pension, which Capita cannot resolve, please contact the Group Secretary for initial advice. More complicated matters are dealt with by David Luxton, the Pensions & Personal Case Manager at CSPA HQ.

The earlier contractor (MyCSP) experienced problems in recent months delivering its service to the standards expected by the Cabinet Office. CSPA was in close contact with the Cabinet Office to help ensure that the transition from MyCSP to Capita went seamlessly. Unfortunately, there

were problems from the outset, partly caused by the backlog of work handed over by MyCSP, including the large amount of work arising from the McLeod judgement. CSPA has been in contact throughout January with Capita and the Cabinet Office about the unacceptable situation. Capita and the Cabinet Office jointly issued a detailed update on 28 January about their efforts to tackle the backlog and restore normal service: <https://www.capita.com/news-and-insights/news/2026/joint-statement-civil-service-pension-scheme-csps>. Capita will soon launch an App, for use on all Android and iOS phones and tablets, for easy access to the pension portal.

### **CSPA NATIONAL AGM 2026**

CSPA National AGM 2026 will be held in early October in Kenilworth. At our June and September Group meetings we will appoint our Group delegate, consider making nominations for national elections, decide whether to submit any motions for discussion, and give our delegate a steer on how to vote on the key motions on the National AGM agenda.

### **“LATER LIFE AMBITIONS” (LLA) CAMPAIGNS**

“Later Life Ambitions” (LLA) represents the 160,000 members of the CSPA, the National Federation of Occupational Pensioners (NFOP), and the National Association of Retired Police Officers (NARPO). Its manifesto - <https://www.laterlifeambitions.co.uk/manifesto> - was launched at a Westminster Parliamentary event in November 2023 and sets out 6 aims for a better future for the 11 million older people in the UK. LLA recently published its “Budget for Later Life” – <https://www.laterlifeambitions.co.uk/copy-of-our-manifesto> - seeking to:

- Protect the State Pension
- Reduce the tax on pensions
- Tackle the gender pension gap
- Support older people in the workplace
- Introduce a minimum income guarantee
- Widen access to public transport
- Make housing safe, secure, and accessible
- Support health and social care

### **THE NATIONAL PENSIONERS CONVENTION (NPC)**

CSPA is affiliated to the National Pensioners Convention (NPC), the largest pensioners organisation in the UK. NPC campaigns for the welfare and interests of pensioners and older people, as a way of securing dignity, respect, and financial security in retirement. It organises rallies, lobbies of MPs, and makes submissions to Government on relevant issues. Its 2024 Biennial Delegate Conference elected the NPC national officers and determined its policies and priorities until 2026. NPC also stages an annual 2-day “Pensioners Convention” in Blackpool. Sadly, current financial difficulties meant that the 2025 event was postponed. NPC’s monthly bulletin “Campaign!” is sent by the Group Secretary to our email group. ### **APPEAL FOR VOLUNTARY DONATIONS**
